ADMISSION MODALITIES FOR ADMISSION TO THE FIVE-YEAR INTEGRATED POST GRADUATE PROGRAMME (FYIPGP) FOR THE 2024-2025 SESSION (REVISED)

1. For admission to the Five-Year Integrated Post Graduate Programme (FYIPGP) of Dibrugarh University, the following two criteria shall be followed:

Criterion 1(a):

50% of the total seats in each Department/Centre of Dibrugarh University shall be filled up based on the performance of the candidates in the **Common University Entrance Test for Under Graduate (CUET-UG)** programmes in the relevant discipline conducted by National Testing Agency (NTA).

Basic Eligibility Criterion

A minimum of 60% aggregate percentage of marks or equivalent grade in (10+2) examination for General Category and 55% aggregate percentage of marks or equivalent grade in (10+2) examination for the SC/ST/OBC/EWS/PWD candidates will be considered as eligibility criterion.

In case of admission under criterion 1(a), allotment of Major will be done only on the basis of CUET UG score in the concerned subject. *However, for the candidates opting for the below mentioned programmes, preference will be given in allotment of Major as per the following details:*

- (a) For FYIPGP in Commerce, preference will be given to candidates having Accountancy/Business Studies as one of the subjects in the 10+2 examination.
- (b) For FYIPGP in Life Sciences (Botany) and FYIPGP in Life Sciences (Zoology), preference will be given to candidates having Biology as one of the subjects in the 10+2 examination.
- (c) For FYIPGP in Statistics, preference will be given to candidates having Mathematics/Statistics/Applied Mathematics as one of the subjects in the 10+2 examination.

Criterion 1(b):

Remaining 50% of the seats in each Department/Centre of Dibrugarh University shall be filled up on the basis of merit in the (10+2) examination conducted by the recognized boards/councils as below.

Basic Eligibility Criteria

A minimum of 60% aggregate percentage of marks or equivalent grade in (10+2) examination for General Category and 55% aggregate percentage of marks or equivalent grade in (10+2) examination for the SC/ST/OBC/EWS/PWD candidates will be considered as eligibility criterion.

Selection Criteria

- (a) Merit list shall be prepared based on the aggregate percentage in Best Five (05) subjects in 10+2 examination.
 - (b) In case of two or more candidates securing an equal percentage of marks in 10+2 examination, merit shall be determined based on aggregate percentage in class 10 examination.
2. If any seat remains vacant under either of the above two criteria [say 1(a)], the same may be filled from the eligible candidates from the other criterion [say 1(b)]. For example, vacant seats under criterion 1(a) shall be filled up from criterion 1(b) and vice-versa.
 3. If a candidate is admitted to a programme under criterion 1(a), he/she shall not be allowed to take admission under criterion 1 (b) and vice-versa.
 4. Statutory Reservation Policy shall be followed as per the Government Rules by the University while preparing the Merit List of the candidates.
 5. For any matter not covered by the above clauses, the decision of the Competent Authority shall be final and binding.
